If you generate and export more energy to the grid than your home consumes (Excess Energy Exported), you will get a bill credit for the amount of net excess energy exported (Excess Energy Credit), based on your utility meter data. You will get an Excess Energy Credit on your bill based on the excess number of kWh exported multiplied by the real-time settlement point price for your congestion zone at the time of export, capped at 25¢ per kWh, which will be displayed on your monthly bill at a single price point representing the average of all price points applied during the time of billing. This plan is for customers who consistently generate more kilowatt hours than they consume. Net exporters, who customers who consistently generate more than they consume, do qualify for this plan.
